A RESOLUTION AWARDED A CONTRACT (FY2019-056) TO JENKINS & STILES, LLC, KNOXVILLE, FOR THE CONSTRUCTION OF THE OAK RIDGE PRE-KINDERGARTEN AND SCARBORO PARK IMPROVEMENTS PROJECT IN AN AMOUNT NOT TO EXCEED \$8,410,000.00 AND AUTHORIZING THE CITY MANAGER TO SIGN CHANGE ORDERS UP TO FIVE PERCENT (5%) OVER THE CONTRACT PRICE.
