AN ORDINANCE TO AMEND ORDINANCE NO. 21-82, AS AMENDED, BY DELETING THE PROVISION OF SECTION 13 PERTAINING TO THE SCHEDULE OF WASTEWATER RATES IN ITS ENTIRETY, AND SUBSTITUTING THEREFOR A NEW SCHEDULE OF WASTEWATER RATES, AND TO CHANGE ALL REFERENCES TO “WASTEWATER” TO “SEWER” FOR CLARITY AND EASE OF UNDERSTANDING.
